RESOLUTION NO. 2660

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF TOLLESON, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON JULY 21, 2026.

WHEREAS, the City of Tolleson, Maricopa County, Arizona, held a Primary Election on the 21st day of July 2026 (the "Election") for the election of three Council Members; and

WHEREAS, the Election returns have been presented to and have been canvassed by the City of Tolleson, Maricopa County, Arizona.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF TOLLESON, ARIZONA, as follows:

Section 1. The recitals above are hereby incorporated as if fully set forth herein.

Section 2. The total number of ballots cast at the Election was 667.

Section 3. The total number of ballots rejected was five (5), consisting of one (1) rejected early ballot and four (4) rejected provisional ballots.

Section 4. The votes cast for the candidates for three Council Member seats were as follows:

Section 5. The majority of votes cast, as calculated pursuant to A.R.S. § 9-821.01, is 274 votes. It is hereby found, determined and declared of record that the following three candidates each received a majority of the votes cast and are hereby declared elected and shall be issued Certificates of Election:

Jimmy Davis for Council Member
Clorinda Contreras Erives for Council Member
Diana Ledesma Ruiz for Council Member

Section 6. This Resolution shall constitute the official canvass and be in full force and effect immediately upon its adoption.

Section 7. The Mayor, City Manager, City Clerk and City Attorney are hereby authorized and directed to take all steps necessary to carry out the purpose and intent of this Resolution.
